## Proposed Changes to Postmark and Postal Possession Rules

The U.S. Postal Service has proposed new rules regarding postmarks and postal possession. These changes impact the date a tax return is considered filed or a payment is considered made under IRC Section 7502.

### What You Need to Know:

#### Timely Mailing Equals Timely Filing:

- Under current rules, the timely mailing of a tax return or payment is treated as timely filing and payment.
- The proposed rules clarify that the date a tax return or payment is delivered to a local post office may not always match the postmark date.

#### Postmark Date Explained:

- Postmarks represent the date a mail piece is accepted at a retail location or processed at a facility.
- The postmark date may not always reflect the actual date the Postal Service first accepted possession of the mail piece.

#### Ensuring Timely Filing:

- To guarantee timely filing or payment, taxpayers are advised to request a postmark at a postal retail location.
- Certified mail or services like Certificate of Mailing can provide a receipt with the date the Postal Service first accepted the mail piece.

### Recommendations for Taxpayers:

- Utilize online payment systems through [irs.gov/payments](https://irs.gov/payments) and [my.path.pa.gov](https://my.path.pa.gov)
- Visit a postal retail location to request a postmark on your mail piece.
- Use certified mail or other services that provide proof of mailing date.
- Avoid relying solely on machine-applied postmarks from processing facilities, as these may not reflect the actual mailing date.
