How to Check Status of Federal & Pennsylvania Tax Refunds

Federal Tax Refund Status

Taxpayers who have filed their federal income tax return and are expecting a refund have several ways to monitor its progress. The IRS now offers an enhanced feature within the [Individual Online Account](#) that allows taxpayers to opt in to receive email notifications whenever their refund status changes. Those who prefer not to sign in can still use the [Where's My Refund?](#) tool on IRS.gov to check their status at any time. Refund information is also available through the IRS2Go mobile application, which provides secure access to updates.

For individuals who prefer phone assistance, the IRS provides automated hotlines. Refund inquiries can be made by calling [800-829-1954](#), while questions about amended returns can be directed to [866-464-2050](#). In most cases, refund status becomes available within 24 hours of e-filing a current-year return, and the majority of refunds are issued in fewer than 21 days.

Refunds may take longer to process when additional review is required. Common causes include missing signatures, mathematical errors, incomplete direct deposit information, or filing an amended return. Claims involving the Additional Child Tax Credit or requests for injured spouse relief also require more extensive manual review, which can extend processing time.

Pennsylvania State Tax Refund Status

Taxpayers who filed a Pennsylvania state income tax return can check the status of their refund through the Pennsylvania Department of Revenue. The most convenient option is the online refund status tool available at [myPATH.pa.gov](#). By selecting "[Where's My Refund?](#)" and entering a Social Security Number along with the exact expected refund amount, taxpayers can view the most current information.

Refund status is also available through the Department of Revenue's automated phone system at 1-888-PATAXES ([1-888-728-2937](#)). Additionally, individuals who create or log in to a myPATH account can access refund updates, notices, and correspondence directly within the portal.

Most Pennsylvania refunds are processed within four to six weeks, although paper-filed returns may require additional time. Delays can occur when documentation is missing, identity verification is needed, or errors are identified on the return.
